Dear Investor,

You are receiving this notice because you were an investor in a reporting share class of one or both of the above-named funds on 31 January 2018.

Each class of shares of the above named funds is registered with HM Revenue & Customs in the UK as a "reporting fund". As such, Trojan Funds (Ireland) plc is required to make reports of income to the investors. There may be a requirement for you to pay tax as though you had actually received a distribution from the relevant fund.

If you are not subject to UK taxation, you may ignore this notice. If you are subject to UK taxation (unless you are a non-domiciled individual paying tax on the remittance basis), you will be required to pay tax on the share of income reported to you in this notice. If you are uncertain you should seek advice from your tax advisor.

For UK tax purposes, you are treated as receiving income on the relevant "fund distribution date" set out in (d) below. Therefore, you should include this income in your tax return for the tax year which includes that date.

The amount of income treated as received by you will be the "Excess" reported in (b) below, multiplied by the number of shares you held at 31 January 2018.

The table overleaf comprises the report of income as required for UK purposes, with the columns having the following meanings:

- a) amount per share actually distributed to participants
- b) excess of reported income per share over amount actually distributed
- c) dates on which distributions were made
- d) fund distribution date
- e) the fund continues to be a reporting fund at the present date
