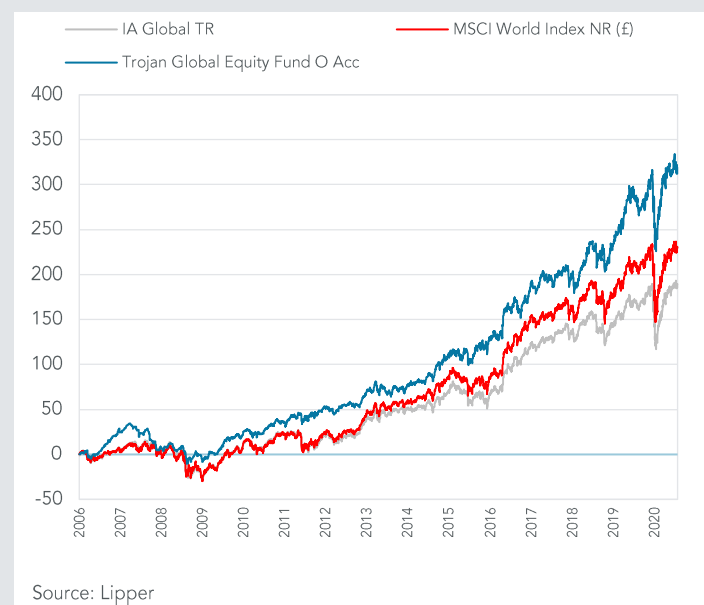

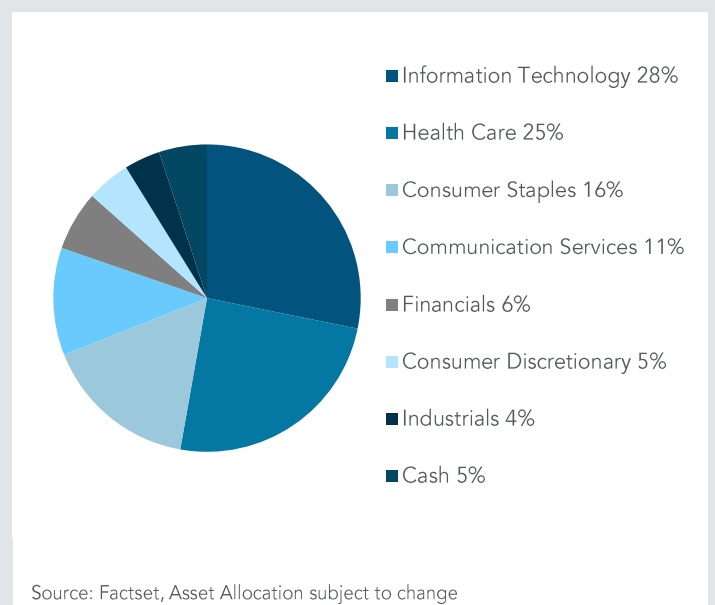

September Commentary

Your Fund returned -1.1% during the month compared to +0.0% for the MSCI World Index NR (£).

We regularly encounter the mistaken belief that all higher quality businesses have become too expensive. Some companies will need to recover lost earnings to demonstrate their value. Last month we highlighted Medtronic as inexpensive as it seeks to emerge stronger after the impact of the pandemic. A similar case can be made for American Express and Heineken, both of which also appear good value with any normalisation of earnings.

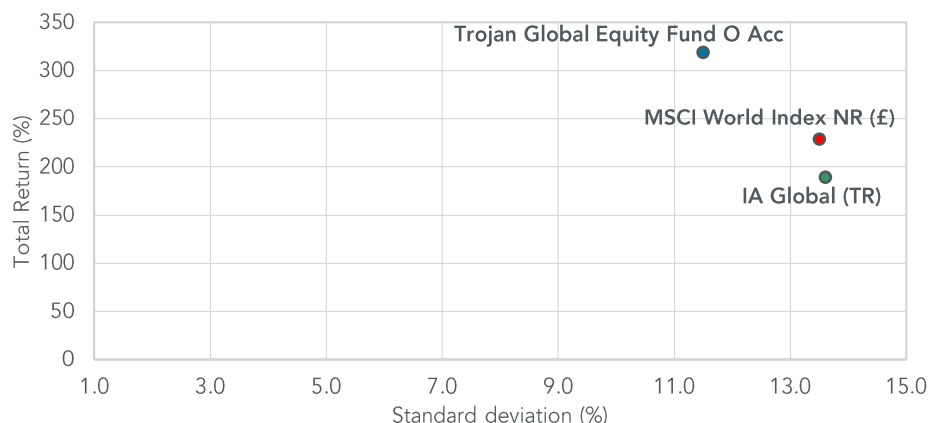
In these instances we take a long-term perspective to assume a recovery eventually takes hold. Heineken and Amex have each been in business for over 150 years, surviving many crises along the way. We can be confident they will bounce back from this one to reward investors' patience. The timing of this is unpredictable.

For Roche, a mere 124 years old, we need make no such assumptions. The company's earnings have been relatively resilient over the last six months due to consistent demand for its products. Indeed, its world-leading diagnostics business should receive a lasting boost from covid-related testing. This month

we attended an online investor day for its core pharmaceuticals division. We remain highly impressed by the depth and breadth of Roche's existing product portfolio and the scale of its investment into R&D. We believe these strengths combine with the growing relevance of its data and diagnostics assets to overwhelm any lingering concerns about generic competition for its older medicines. Roche's shares have an appealing free cash flow* yield of 6%, making them another important source of value for the Fund.

*The free cash flow yield is the free cash flow generated by the company divided by its market value.
